The paving will apparently be done in the Village before the lower switchback area of the main road. The Ministry of Transportation and Infrastructure contact is Danny Morris.

Sandy talked to Norm Crerar that day has not had a great response from residents. He does have some though to put something together. He needs to know numbers for the stratas. Ted will ask Loreen to send out a notice to members to send invoice information to Norm Crerar.
