a. Financial/Budget – Sheryl

Budget: The previous budget numbers are pretty good. For the most part they can be entered for the next budget. New budget item: Mike MOVED that we budget \$8,000 for the Silverhawk file. Ron, SECONDED. Discussion: It is estimated that the lawyer's fees will be approximately \$7,500. The report will be ready for the AGM which should be welcome by many people who are frustrated with the issues. The committee has recommended we pursue the options through legal opinion and this should help bolster our request to speak with the Minister responsible. We had a meeting with Eric Foster who is supposed to introduce us to the Minister. This has not yet happened. We should add the line item as Legal Fees: CARRIED

b. Member Engagement-Website Update - Mike/Loreen -Newsletter with renewal reminder

When we have our AGM the renewal is for the year ending September 30th. Our membership renewal will include a printed list of those who are paid. If not paid then they will be asked to fill in a form giving us the information for our lists. They will have until January 30th.to pay if they want.

c. Utility Services – Mike – Star Gas & BCUC update. We still have two outstanding decisions. Mike phoned two weeks ago. We should be getting the final decisions in the next few days. Matt has told us they can't sell Silverhawk without going to the Utilities Commission. If they go to the Commission he thinks we should apply for intervener status.

Silverhawk – We met with Mr. Foster to help identify all the people who are in the same position as we are. Ministry of Environment and Climate Change Strategy contact has provided Silverhawk Annual Reports since 2007. Our goal will get the government to regulate these utilities.

We need to touch base with them every year to remind the Ministry of Highways/City that the side-line marking needs to be done. Ron will contact them again in March.
